## **About the Elections Office of the Registrar of Voters:**

The Elections Office of the ROV is responsible for all aspects of the election process for all local, state, and federal elections in the County of San Bernardino. This includes the storage and maintenance of voter registration records, employment of and training for poll workers, accessibility surveys for polling locations that best meet the needs of the electorate, management of voting system security and election ballot processing and vote tallying.

San Bernardino is the largest county, area wise, in the contiguous United States. The County boasts more than 800,000 registered voters. The Elections Office staff typically operates with approximately 24 employees, but before elections, that number may swell to more than 400. This includes both temporary and part time employees, and also is complemented by the 1000's of election workers who staff the polling places on Election Day.
